ORDER TERMS AND CONDITIONS

Pursuant to (i) these terms and conditions; and (ii) the Wix Enterprise Plan Order Form (the "Order"), the Customer identified in the Order ("Customer") shall purchase from Wix.com Ltd ("Wix") the type and quantity of subscriptions to Basic Enterprise Plans on Wix Platform set out in the Order ("Subscriptions") (a general description of Wix Basic Enterprise Plan is attached hereto as Exhibit A). Any request by Customer for a purchase of ancillary professional services or other/advanced services related to the Wix platform ("Services") shall be negotiated directly with Wix and shall be subject to Wix and Customer's signature on a separate agreement, which will be subject to the terms of Section 8 below ("Services Agreement"). The Subscriptions and Services shall be collectively referred to as the "Purchased Solutions". The purchase and the use of the Purchased Solutions are subject to, and in accordance with, the Order and the terms and conditions set forth below ("Order Terms and Conditions"), and shall be governed at all times by the Wix Terms of Use at: https://www.wix.com/about/terms-of-use, and the Wix Privacy Policy at: https://www.wix.com/about/privacy, both, as may be amended from time to time pursuant to the respective terms ("Wix General Terms of Use", and collectively with this Order Terms and Conditions, the "Terms"). In the event of a contradiction between the Order and the Order Terms and Conditions and/or Wix General Terms of Use, the respective terms of the Order shall prevail. In the event of a contradiction between the Wix General Terms of Use and this Order Terms and Conditions, the respective terms of this Order Terms and Conditions shall prevail. 4. **Cancellation by Wix.** Without derogating from Wix rights and remedies hereunder and/or under the Terms and/or under applicable laws, Wix shall have the right in its sole discretion and without prior notice, to cancel the Order and/or suspend any Service and/or any use by Customer of the Purchased Solutions (or any part or portion thereof) at any time, for failure to pay in full any sums due pursuant to the Order.

- 5. Intellectual Property Rights.
