Terms Of Service

Laravel Holdings Inc. ("Laravel Forge", "**we**", "**us**" or "**our**") agrees to furnish services to the Subscriber (the "**Subscriber**", "**you**" or "**your**"), subject to the following Terms of Service. Use of Laravel Forge's service constitutes acceptance and agreement to Laravel Forge's Terms of Service.

Laravel Forge reserves the right to modify the Terms of Service without notice.

Use of Services

You may use our services, provided that you are of legal age to form a binding contract and are not barred from receiving such services under the laws of the United States or other jurisdictions. In order to access our services, you are required to provide current and factual identification, contact, and other information as part of the registration process. You are responsible for the confidentiality of your account information and for all activities that occur under your account. You are solely responsible for all content within your account. You agree to immediately notify Laravel Forge of any unauthorized use of your account or any other breach of security. Laravel Forge will not be liable for any loss or damage as a result of your failure to provide us with accurate information or to keep your account secure.

Acceptable Conduct

You are responsible for the actions of all users of your account and any data that is created, stored, displayed by, or transmitted by your account while using Laravel Forge. You will not engage in any activity that interferes with or disrupts Laravel Forge's services or networks connected to Laravel Forge.

Prohibited Usage

You agree that any of the below activities are considered prohibited usage and will result in immediate account suspension or cancellation without a refund and the possibility that Laravel Forge will impose fees; and/or pursue civil remedies without providing advance notice.

Misuse of System Resources: Intentional misuse of system resources, including but not limited to employing programs that consume excessive network capacity, CPU cycles, or disk IO.

Access to Other Computers or Networks without Authorization: Attempting unauthorized and/or ill-gotten access of computers, networks and/or accounts not belonging to party seeking access. Any act which interferes with the services of another user or network. Any act relating to the circumvention of security measures.



Laravel Forge and the services it provides may only be used for lawful purposes. Transmission, distribution, or storage of any information, data or material in violation of United States or state regulation or law, or by the common law, is prohibited. This includes, but is not limited to, material protected by copyright, trademark, trade secret, or other intellectual property rights. Laravel Forge's services may not be used to facilitate infringement of these laws in any way.

Other Activities viewed as Illegal or Harmful: Engaging in illegal activities or engaging in activities harmful to the operations of Laravel Forge or Laravel Forge's customers.

Providing False Data on any Contract or Application: including fraudulent use of credit card numbers.

Invoicing And Payment

You agree that Laravel Forge shall be permitted to charge your credit card on a monthly, annual, or other agreed upon basis in advance of providing services. Payment is due upon invoicing. Service may be interrupted on accounts that reach 10 days past due. Accounts that are not collectable by Laravel Forge may be turned over to an outside collection agency for collection.

Subscriber is aware that Laravel Forge may prospectively change the specified rates and charges from time to time.

Laravel Forge is not responsible for any additional bank fees, interest charges, finance charges, over draft charges, or other fees resulting from charges billed by Laravel Forge. Currency exchange settlements will be based on agreements between you and the provider of your credit card. Pro-rated credits will not be issued for unused services when customer retains any active service.

Server Provider Fees

You agree that Laravel Forge is not responsible for any additional fees charged to your credit card by third-party server providers such as DigitalOcean, Linode, Amazon, Vultr, or Hetzner.

Support Boundaries

Laravel Forge, provides technical support to our subscribers via our e-mail support system. The following are our guidelines when providing support: Laravel Forge provides support related to your Laravel Forge created virtual server physically functioning. Laravel Forge does not offer technical support for application specific issues such as application configuration, programming, web or mail server configuration, or any other such issue. Laravel Forge does not provide technical support to your customers.

Account Cancellation Or Suspension

Laravel Forge reserves the right to suspend network access to any customer if, in the judgment of the Laravel Forge network administrators, the customer's server is the source or target of a violation of any of the other terms of service or for any other reason which Laravel Forge chooses. Laravel Forge will use reasonable care in notifying the Customer and in resolving the problem in a method resulting in the least amount of service interference. Laravel Forge reserves the right to terminate service without notice for continued and repeated violations of the terms of service. If inappropriate activity is detected, all accounts of the Customer in question will be deactivated until an investigation is complete. Prior notification to the

Customer is not assured. In extreme cases, law enforcement will be contacted regarding the activity. The customer will not be credited for the time the customer's machines were suspended.

If at any time it becomes necessary for Laravel Forge to cancel a customer's service without cause, Laravel Forge will provide 10 days advance notice.

You may cancel the service at any time by using the "Cancel Subscription" link located on the "My Account" sub-tab of the Laravel Forge web application. Cancellation of service does not relieve Subscriber of responsibility for the payment of all accrued charges.

Disclosure To Law Enforcement

The Terms of Service specifically prohibits the use of our service for illegal activities. Therefore, Subscriber agrees that Laravel Forge may disclose any and all subscriber information including assigned IP numbers, account history, account use, etc. to any court who sends us a valid Court Order, without further consent or notification to the Subscriber. In addition, Laravel Forge shall have the right to terminate all service set forth in this Agreement.

Server Security

Subscriber is solely responsible for maintaining the security of Subscriber's servers that are created via the Laravel Forge service. Laravel Forge shall have no liability for any security breaches or data breaches of Subscriber's servers, even if those servers were initially created and provisioned by Laravel Forge. Laravel Forge does not guarantee the security of any of Subscriber's servers, even if those servers were initially created and provisioned by Laravel Forge.

Backup

Subscriber is solely responsible for the preservation of Subscriber's data which Subscriber saves onto its virtual server (the "**Data**"). Even with respect to Data as to which Subscriber contracts for backup services provided by Laravel Forge, Laravel Forge shall have no responsibility to preserve Data. Laravel Forge shall have no liability for any Data that may be lost.

Choice Of Law And Forum

The Terms of Service and the relationship between you and Laravel Forge shall be governed by the laws of the State of Arkansas without regard to its conflict of law provisions. You and Laravel Forge agree to submit to the personal and exclusive jurisdiction of the courts located within the county of Saline, Arkansas.

Waiver And Severability Of Terms

The failure of Laravel Forge to exercise or enforce any right or provision of the Terms of Service shall not constitute a waiver of such right or provision. If any provision of the Terms of Service is found by a court of competent jurisdiction to be invalid, the parties nevertheless agree that the court should endeavor to give effect to the party's intentions as reflected in the provision, and the other provisions of the Terms of Service remain in full force and effect.

Statute Of Limitations

You agree that regardless of any statute or law to the contrary, any claim or cause of action arising out of or related to use of Laravel Forge services or the Terms of Service must be filed within one (1) year after such claim or cause of action arose or be forever barred.
