Subject to the Licensee's payment of the applicable license fees, Licensor grants to you a limited, non-exclusive, non-transferable, non-assignable sublicense to use a single copy of the Software and Documentation during the term of this Agreement. You agree that you have no right, power, or authority to make any modifications to or unauthorized copies of the Software and Documentation.

- 2. **No Modification; No Reverse Engineering.** You agree not to modify, translate, reverse engineer, decompile, disassemble, or create derivative works of the Software or assist someone in performing such prohibited acts.
