

# End-User License Agreement (“Agreement”)

Please read this End-User License Agreement (“Agreement”) carefully before clicking the “I Agree” button, downloading or using Spherical Defense (“Application”).

By clicking the “I Agree” button, downloading or using the Application, you are agreeing to be bound by the terms and conditions of this Agreement.

This Agreement is a legal agreement between you (either an individual or a single entity) and Spherical Defence Labs Limited and it governs your use of the Application made available to you by Spherical Defence Labs Limited.

If you do not agree to the terms of this Agreement, do not click on the “I Agree” button and do not download or use the Application.

The Application is licensed, not sold, to you by Spherical Defence Labs Limited for use strictly in accordance with the terms of this Agreement.

## License

Spherical Defence Labs Limited grants you a revocable, non-exclusive, non-transferable, limited license to download, install and use the Application solely for your personal, non-commercial purposes strictly in accordance with the terms of this Agreement.

## Restrictions

You agree not to, and you will not permit others to:

- copy or use the Application for any purpose other than as permitted under the above section ‘License’.
- modify, make derivative works of, disassemble, decrypt, reverse compile or reverse engineer any part of the Application.
- remove, alter or obscure any proprietary notice (including any notice of copyright or trademark) of Spherical Defence Labs Limited or its affiliates, partners, suppliers or the licensors of the Application.

## Intellectual Property

The Application, including without limitation all copyrights, patents, trademarks, trade secrets and other intellectual property rights are, and shall remain, the sole and exclusive property of Spherical Defence Labs Limited.

## **Your Suggestions**

Any feedback, comments, ideas, improvements or suggestions (collectively, “Suggestions”) provided by you to Spherical Defence Labs Limited with respect to the Application shall remain the sole and exclusive property of Spherical Defence Labs Limited.

Spherical Defence Labs Limited shall be free to use, copy, modify, publish, or redistribute the Suggestions for any purpose and in any way without any credit or any compensation to you.

## **Modifications to Application**

Spherical Defence Labs Limited reserves the right to modify, suspend or discontinue, temporarily or permanently, the Application or any service to which it connects, with or without notice and without liability to you.

## **Updates to Application**

## **Term and Termination**

This Agreement shall remain in effect until terminated by you or Spherical Defence Labs Limited.

Spherical Defence Labs Limited may, in its sole discretion, at any time and for any or no reason, suspend or terminate this Agreement with or without prior notice.

This Agreement will terminate immediately, without prior notice from Spherical Defence Labs Limited, in the event that you fail to comply with any provision of this Agreement. You may also terminate this Agreement by deleting the Application and all copies thereof from your mobile device or from your computer.

Upon termination of this Agreement, you shall cease all use of the Application and delete all copies of the Application from your mobile device or from your computer.

Termination of this Agreement will not limit any of Spherical Defence Labs Limited's rights or remedies at law or in equity in case of breach by you (during the term of this Agreement) of any of your obligations under the present Agreement.

## **Indemnification**

You agree to indemnify and hold Spherical Defence Labs Limited and its parents, subsidiaries, affiliates, officers, employees, agents, partners and licensors (if any) harmless from any claim or demand, including reasonable attorneys' fees, due to or arising out of your: (a) use of the Application; (b) violation of this Agreement or any law or regulation; or (c) violation of any right of a third party.

## **No Warranties**

## **Amendments to this Agreement**

Spherical Defence Labs Limited reserves the right, at its sole discretion, to modify or replace this Agreement at any time. If a revision is material we will provide at least 30 days' notice prior to any new terms taking effect. What constitutes a material change will be determined at our sole discretion.
