

SOFTWARE LICENSE AGREEMENT FOR MCE SOLUTIONS

Version Date: 1 January, 2024

THIS SOFTWARE LICENSE ("LICENSE") IS AN AGREEMENT BETWEEN YOU, THE END USER ("USER") AND MCE SYS LTD. OR THE APPLICABLE MCE AFFILIATE ("MCE") GOVERNING YOUR RIGHTS TO USE THE LICENSED SOFTWARE. "LICENSED SOFTWARE" MEANS ALL MCE SOFTWARE PRODUCTS COMPONENTS AND SOLUTIONS MARKETED UNDER ANY BRANDING OR BY ANY MCE AFFILIATE, ANY SOFTWARE INCLUDED IN OR WITH MCE PRODUCTS, ACQUIRED BY USER FROM MCE OR A MCE AUTHORIZED DISTRIBUTOR OR RESELLER ("RESELLER") AND ANY UPDATES, UPGRADES, ENHANCEMENTS, MODIFICATIONS, PATCHES, ALTERATIONS, IMPROVEMENTS, CORRECTIONS, REVISIONS, RELEASES OR NEW VERSIONS THEREOF ("UPDATES"). BY ACQUIRING AND/OR USING ANY LICENSED SOFTWARE FORM MCE OR ANY RESELLER, THE USER AGREE TO BE BOUND BY THE TERMS OF THIS LICENSE.

- 1. <u>Grant of License</u>. The User is hereunder granted by MCE a personal, non-exclusive license to Use the Licensed Software and the associated documentation ("**Documentation**"). The "Use" is limited to storing, loading, installing or running copies of the Licensed Software by the User (including its authorized employees, agents or representatives) in accordance with the Documentation for User's internal business purposes and does not include sharing or providing access to the Licensed Software, in any form, to any third party. User acknowledges that the Licensed Software is being licensed to it hereunder, not sold.
- 2. <u>Ownership; IP Rights.</u> MCE retains exclusive ownership of all right, title and interest in the Licensed Software and any intellectual property and/or confidential information embedded therein and/or related, directly and/or indirectly thereto. User is not granted any title or ownership rights in or to the Licensed Software or any portion thereof. All rights to intellectual property granted by this License are explicitly stated. No other rights shall be deemed as granted to User other than the license explicitly granted hereunder.
- 3. <u>User shall</u>: (i) Use the Licensed Software only in the configuration as provided to it; (ii) hold the Licensed Software in confidence for the benefit of MCE using no less a degree of care than it uses to protect its own confidential information but not less than a reasonable degree of care; (iii) notify User's authorized employees, agents, and/or representatives Using the Licensed Software of the requirements of this License and of the confidential nature of the Licensed Software; and (iv) upon termination of this License, return the Licensed Software and the Documentation to MCE or User's Reseller or destroy all copies thereof.
- 4. <u>User shall not</u> (and shall not allow any third party to): (i) reverse engineer, disassemble, reverse translate, decompile, or in any other manner decode the Licensed Software by any means whatsoever and for any reason; (ii) remove any product identification, copyright, patent or other notices; (iii) Use the Licensed Software for any purpose other than User's own internal business purposes and under the terms of this License; (iv) allow anyone other than User's authorized employees, agents and/or representatives to have physical access to the Licensed Software or allow others to use the Licensed Software to or for the benefit of third parties; (v) make any copies of the Licensed Software other than as authorized hereunder; or (vi) make any modifications, enhancements, adaptations, derivative works, or translations to or of the Licensed Software.
- 5. <u>Term and Termination</u>. If User complies with all of the terms and conditions of this License, User may continue to Use the Licensed Software for the term determined in the agreement under which the Licensed Software was supplied to the User by MCE or a Reseller or, as applicable, the license subscription term. This License will terminate automatically without further action upon notice by MCE to User following any breach of this License by User without prejudice to any other rights and remedies that MCE may have at law or equity. Upon such termination, User must immediately cease all use of the Licensed Software and return or destroy all copies of such and all portions thereof (whether or not modified or incorporated with or into other software) and so certify to MCE. Except for the license grant contained herein above, the terms of this License shall survive termination. Termination is not MCE's exclusive remedy, and all other remedies will be available to MCE whether or not this License is terminated.

- 6. WARRANTIES. THE EXPRESS LIMITED WARRANTIES FOR THE LICENSED SOFTWARE WILL BE SOLELY THOSE GRANTED TO USER BY MCE OR USER'S RESELLER IN A SEPARATE AGREEMENT. ALL WARRANTIES PROVIDED BY MCE OR RESELLER SHALL INCLUDE UPDATES. THE LICENSED SOFTWARE IS PROVIDED BY MCE AND ITS SUPPLIERS "AS IS." WITH RESPECT TO THE LICENSED SOFTWARE, MCE AND ITS SUPPLIERS DISCLAIM ALL WARRANTIES AND CONDITIONS OF ANY KIND OR NATURE, WRITTEN OR ORAL, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION, ALL WARRANTIES AND CONDITIONS OF TITLE, NON-INFRINGEMENT, MERCHANTABILITY, AND FITNESS FOR A PARTICULAR PURPOSE AND ALL WARRANTIES ARISING FROM COURSE OF DEALING OR USAGE OF TRADE.
- 7. LIABILITY. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT WILL MCE OR ANY OF ITS SUPPLIERS BE LIABLE UNDER ANY LEGAL THEORY FOR ANY SPECIAL, INCIDENTAL, INDIRECT, OR CONSEQUENTIAL DAMAGES WHATSOEVER (INCLUDING, WITHOUT LIMITATION, DAMAGES FOR LOSS OF BUSINESS PROFITS, BUSINESS INTERRUPTION, LOSS OF BUSINESS INFORMATION, CORRUPTION OR LOSS OF DATA, COST OF PROCUREMENT OF SUBSTITUTE GOODS, SERVICES, OR TECHNOLOGY) AS A RESULT OF USE OR INABILITY TO USE THE LICENSED SOFTWARE OR BREACH OF ANY OTHER TERM OF THIS LICENSE, REGARDLESS OF WHETHER MCE AND/OR MCE'S SUPPLIERS WERE ADVISED, HAD OTHER REASON TO KNOW, OR IN FACT KNEW OF THE POSSIBILITY THEREOF. IN ANY EVENT, MCE'S MAXIMUM LIABILITY FOR DAMAGES ARISING UNDER THIS LICENSE SHALL BE LIMITED TO THE AMOUNT MCE RECEIVED FROM USER FOR THE SPECIFIC LICENSED SOFTWARE CAUSING THE DAMAGE. USER ACKNOWLEDGES AND AGREES THAT THE LIABILITY LIMITATIONS IN THIS LICENSE ARE MATERIAL BARGAINED FOR BASES OF THIS LICENSE AND THAT USER AND MCE (OR THE RESELLER) HAVE TAKEN THEM INTO ACCOUNT IN DETERMINING THE CONSIDERATION TO BE PAID UNDER THIS LICENSE AND IN THE DECISION BY MCE AND USER TO AGREE TO THIS AGREEMENT.
- 8. <u>STATISTICAL INFORMATION</u>. USER ACKNOWLEDGES AND AGREES THAT MCE SHALL BE ENTITLED TO COLLECT INFORMATION AND STATISTICS REGARDING THE USE OF THE LICENSED SOFTWARE BY USER. TO REMOVE ANY DOUBT IT IS HEREBY CLARIFIED THAT NEITHER MCE NOR ANY LICENSED SOFTWARE COLLECTS ANY CONTENT OR INFORMATION FROM ANY MOBILE DEVICE TREATED WITH THE LICENSED SOFTWARE.
- 9. <u>No Assignment</u>. Neither this License nor any rights acquired by User through this License are assignable. Any attempted assignment of rights or other transfer of the Licensed Software not specifically allowed shall be void and considered as a breach of this License.
- 11. <u>General</u>. This License constitutes the entire agreement between MCE and User with respect to the rights and obligations set forth herein and supersedes all prior or contemporaneous understandings or agreements, written or oral, regarding such subject matter. No amendment to or modification of this License will be binding unless in writing and signed by a duly authorized representative of MCE. This Agreement shall be deemed to have been made in, and shall be construed pursuant to the laws of the State of Israel, without regard to conflicts of laws provisions thereof and without giving effect to the United Nations Convention on Contracts for the International Sale of Goods. The sole jurisdiction and venue for any dispute regarding the terms of this Agreement or any action relating to the subject matter hereof shall be the courts in the Tel-Aviv, Israel.
