END USER LICENSE AGREEMENT

THIS END USER LICENSE AGREEMENT ("LICENSE") IS AN AGREEMENT BETWEEN THE END USER SIGNING AT THE END HEREOF ("USER") AND THAT'S IT LTD ("THAT'S IT") GOVERNING THE USER'S RIGHTS TO USE THE LICENSED SOFTWARE. "LICENSED SOFTWARE" MEANS ALL THAT'S IT SOFTWARE PRODUCTS COMPONENTS AND SOLUTIONS, ANY SOFTWARE INCLUDED IN OR WITH THAT'S IT PRODUCTS, ACQUIRED BY USER FROM THAT'S IT OR A THAT'S IT AUTHORIZED DISTRIBUTOR OR RESELLER OR SUB-DISTRIBUTOR OR SUB-RESELLER MENTIONED IN THE RELEVANT **PURCHASE** ORDER (COLLECTIVELY "RESELLER") AND ANY UPDATES, UPGRADES, ENHANCEMENTS, MODIFICATIONS, PATCHES, ALTERATIONS, IMPROVEMENTS, CORRECTIONS, REVISIONS, RELEASES OR NEW VERSIONS THEREOF ("UPDATES"). BY ACQUIRING AND/OR USING ANY LICENSED SOFTWARE FORM THAT'S IT OR ANY RESELLER, THE USER AGREES TO BE BOUND BY THE TERMS OF THIS LICENSE. THIS LICENSE SHALL BE READ IN CONJUNCTION WITH THE SERVICE ORDER OR A SIMILAR INSTRUMENT EXECUTED BETWEEN THAT'S IT OR A RESLLER AND THE USER. WHICH SERVICE ORDER SETS FORTH THE COMMERCIAL UNDERSTANDINGS BETWEEN THE PARTIES THERETO (THE "SERVICE ORDER")

1. Grant of License. The User is hereunder granted by THAT'S IT a personal, non-transferable non-exclusive license to Use the Licensed Software and the associated Service Order including annexures hereto and thereto for the implementation of an IT Care Center for the User ("Documentation"). The "Use" is limited to storing, loading, installing or running copies of the Licensed Software by the User (including its authorized employees, agents or representatives provided that the User shall be responsible for their use thereof and their compliance with the terms hereof) in accordance with the Documentation for User's internal business purposes and does not include sharing or providing access to the Licensed Software, in any form, to any third party. User acknowledges that the Licensed Software is being licensed to it hereunder, not sold. User shall have the right to make a reasonable number of copies of the Licensed Software for internal back-up purposes only.

Please be advised that (i) the Licensed Software includes proprietary software and certain databases of Oracle Israel ("Oracle") which databases may only be used together with the Licensed Software (ii) the Licensed Software may include source code that Oracle may provide as part of its standard shipment of its software programs, which source code shall be governed by the terms hereof and (iii) only to the extent party technology necessary for use with some Oracle programs is expressly specified in the Documentation, such third party technology is licensed only for use with the Licensed Software under the terms of the third party license agreement expressly specified in the Documentation and not under the terms hereof.

2. Ownership; IP Rights. THAT'S IT or its licensors (including Oracle only with respect to the embedded Oracle databases) retain/s exclusive ownership of all right, title and interest in the Licensed Software and any intellectual property and/or confidential information embedded therein and/or related, directly and/or indirectly thereto. User is not granted any title or ownership rights in or to the Licensed Software or any portion thereof. All rights to intellectual property granted by this License are explicitly stated. No



other rights shall be deemed as granted to User other than the license explicitly granted hereunder. Any third party owning any intellectual property rights in Licensed Software including Oracle with respect to the embedded Oracle databases, is intended to be a third-party beneficiary of this License.

3.**User shall**: (i) Use the Licensed Software only in the configuration as provided to it by THAT'S IT or Reseller; (ii) hold the Licensed Software in confidence for the benefit of THAT'S IT using no less a degree of care than it uses to protect its own confidential information but not less than a reasonable degree of care; (iii) be responsible for ensuring that User's authorized employees, agents, and/or representatives Using the Licensed Software comply with the requirements of this License; and (iv) upon termination of this License, return the Licensed Software and the Documentation to THAT'S IT or User's Reseller or destroy all copies thereof.

4. User shall not (i) transfer any of the Licensed Software except for temporary transfer in the event of computer malfunction if the Licensed Software is embedded in a physical device; (ii) assign, give, or transfer the Licensed Software and/or any services ordered or an interest in them to another individual or entity (in the event the end user grants a security interest in the Licensed Software and/or any services, the secured party has no right to use or transfer the Licensed Software and/or any services; (iii) reverse engineer, disassemble, reverse translate, decompile, or in any other manner decode the Licensed Software by any means whatsoever and for any reason including without limitation, review of data structures or similar materials produced by programs) and duplication of the Licensed Software except for a sufficient number of copies of each Licensed Software for the end user's licensed use and one copy of each program media; (iv) use the Licensed Software for rental, timesharing, subscription service, hosting, or outsourcing; (v) allow title to the Licensed Software from passing to the end user or any other party (vi) remove any product identification, copyright, patent or other notices or any notice of Oracle's or its licensors' proprietary rights; (vii) use the Licensed Software for any purpose other than User's own internal business purposes and under the terms of this License; (viii) make available or allow anyone other than User's authorized employees, agents, sub-contractors and/or representatives to have physical access to the Licensed Software or allow others to use the Licensed Software to or for the benefit of third parties in any manner to any third party for use in the third party's business operations; (ix) make any copies of the Licensed Software other than as authorized hereunder; (x) make any modifications, enhancements, adaptations, derivative works, or translations to or of the Licensed Software and (xi) use the Oracle databases embedded in the Licensed Software without the Licensed Software and not for any purpose other than in connection with the Licensed Software

5. Review of Compliance with License THAT'S IT may at any time conduct or allow to conduct Oracle a review of User's use of the Licensed Software solely in the cloud in order to detect installations and use of unlicensed or otherwise infringing copies of the Licensed Software. The review will be conducted electronically solely in the cloud utilizing the audit functionality of the Licensed Software, designed to enable THAT'S IT to automatically monitor the use of the Licensed Software. The User expressly agrees and consents to such monitoring. If the Audit results determine that the User is not in compliance with the terms of the License, the User shall immediately remedy such noncompliance, whether through purchase and payment for additional Licenses, or otherwise failing which the licenses will be removed by THAT'S IT.



6.Term and Termination.

6.1 In the event of a material breach of this Agreement and/or Documentation by THAT'S IT, User may terminate this Agreement, upon 14 days advance written notice provided that by the end of the said period, such breach has not been cured except for any error or defect defined as a "Critical "in the Documentation in which event, the User shall be entitled to terminate this Agreement even if the error or defect is corrected within such 14-day period. In the event that the User terminates the Agreement due to a material breach as stated above, the User will be entitled to receive the relative portion of the price of the licenses paid in advance for the period from the date of termination of the Agreement until the end of the payment period and User's right to terminate the Agreement and receipt of the relative refund as aforesaid constitutes the User's sole remedy in the event of such breach.

6.2 In the event of any breach of any of the provisions of this Agreement and/or Documentation by the User and/or anyone acting on its behalf, THAT'S IT may, without derogating from any remedy and/or other right in accordance with the provisions of this Agreement and/or any law, terminate this Agreement, upon 14 days advance written notice, provided that such breach is not cured during the said period.

6.3 Upon such termination, User must immediately cease all use of the Licensed Software and return or destroy all copies of such and all portions thereof (whether or not modified or incorporated with or into other software) and so certify to THAT'S IT and THAT'S IT will remove Licensed Software from the cloud. In the event of termination of the License, the User shall immediately cease using the Oracle databases embedded in the Licensed Software and shall remove same from its servers and hardware and shall certify to THAT'S IT, in writing that it has done so. Except for the license grant contained herein above, the terms of this License shall survive termination. Termination is not THAT'S IT's exclusive remedy in the event that the User breaches the terms hereof, and all other remedies will be available to THAT'S IT whether or not this License is terminated. If there is any conflict between this section 6 and Section 7 of the Documentation, this Section 6 shall prevail.

7.WARRANTIES. THE EXPRESS LIMITED WARRANTIES FOR THE LICENSED SOFTWARE WILL BE SOLELY THOSE GRANTED TO USER BY THAT'S IT OR USER'S RESELLER IN THE DOCUMENTATION. SUBJECT TO THE ABOVE, THE LICENSED SOFTWARE IS PROVIDED BY THAT'S IT AND ITS SUPPLIERS "AS IS." SUBJECT TO THE ABOVE, WITH RESPECT TO THE LICENSED SOFTWARE, THAT'S IT AND ITS SUPPLIERS DISCLAIM ALL WARRANTIES AND CONDITIONS OF ANY KIND OR NATURE, WRITTEN OR ORAL, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION, ALL WARRANTIES AND CONDITIONS OF TITLE, NON-INFRINGEMENT, MERCHANTABILITY, AND FITNESS FOR A PARTICULAR PURPOSE AND ALL WARRANTIES ARISING FROM COURSE OF DEALING OR USAGE OF TRADE.

8. LIMITATION OF LIABILITY. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT WILL THAT'S IT OR ANY OF ITS SUPPLIERS INCLUDING WITHOUT LIMITATION, ORACLE, OR THE USER BE LIABLE UNDER ANY LEGAL THEORY FOR ANY SPECIAL, INCIDENTAL, INDIRECT, PUNITIVE OR CONSEQUENTIAL DAMAGES WHATSOEVER (INCLUDING, WITHOUT LIMITATION, DAMAGES FOR LOSS OF BUSINESS PROFITS, LOSS OF REVENUES, BUSINESS INTERRUPTION, LOSS OF BUSINESS INFORMATION, CORRUPTION



OR LOSS OF DATA OR DATA USE, COST OF PROCUREMENT OF SUBSTITUTE GOODS, SERVICES, OR TECHNOLOGY) AS A RESULT OF USE OR INABILITY TO USE THE LICENSED SOFTWARE OR BREACH OF ANY OTHER TERM OF THIS LICENSE, REGARDLESS OF WHETHER THAT'S IT AND/OR THAT'S IT'S SUPPLIERS WERE ADVISED, OR THE USER HAD OTHER REASON TO KNOW, OR IN FACT KNEW OF THE POSSIBILITY THEREOF.

USER'S SOLE REMEDY AGAINST THAT'S IT FOR ANY BREACH OF THIS LICENSE SHALL BE TERMINATION OF THE AGREEMENT PURSUANT TO SECTION 6 ABOVE AND THAT'S IT'S MAXIMUM LIABILITY ARISING UNDER THIS LICENSE SHALL BE LIMITED TO THE RECEIPT OF A REFUND FOR PREPAID LICENSES FOR THE PERIOD FROM THE DATE OF TERMINATION UNTIL THE END OF THE PAYMENT PERIOD EXCEPT FOR CLAIMS AGAINST THE USER ARISING FROM ANY THIRD PARTY CLAIMS RELATING TO A BREACH BY THAT'S IT OF ITS INTELLECTUAL PROPERTY RIGHTS IN THE LICENSED SOFTWARE.

USER'S MAXIMUM LIABILITY TO THAT'S IT ARISING UNDER THIS LICENSE SHALL BE LIMITED TO THE AMOUNT THAT'S IT RECEIVED FROM USER UNDER THIS AGREEMENT EXCEPT FOR CLAIMS AGAINST USER BY THAT'S IT ARISING FROM ANY THIRD-PARTY CLAIMS AGAINST THAT'S IT RELATING TO A BREACH OF THIS LICENSE BY USER.

USER ACKNOWLEDGES AND AGREES THAT THE LIABILITY LIMITATIONS IN THIS LICENSE ARE MATERIAL BARGAINED FOR BASES OF THIS LICENSE AND THAT USER AND THAT'S IT (OR THE RESELLER) HAVE TAKEN THEM INTO ACCOUNT IN DETERMINING THE CONSIDERATION TO BE PAID UNDER THIS LICENSE AND IN THE DECISION BY THAT'S IT AND USER TO AGREE TO THIS AGREEMENT.

9. No Assignment. Neither this License nor any rights acquired by User through this License are assignable. Any attempted assignment of rights or other transfer of the Licensed Software not specifically allowed shall be void and considered as a breach of this License.

10.General. This Documentation constitute the entire agreement between THAT'S IT and User with respect to the rights and obligations set forth herein and supersedes all prior or contemporaneous understandings or agreements, written or oral, regarding such subject matter. No amendment to or modification of this License will be binding unless in writing and signed by a duly authorized representative of THAT'S IT. This Agreement shall be deemed to have been made in, and shall be construed pursuant to the laws of the State of Israel, without regard to conflicts of law's provisions thereof and without giving effect to the United Nations Convention on Contracts for the International Sale of Goods. The sole jurisdiction and venue for any dispute regarding the terms of this Agreement or any action relating to the subject matter hereof shall be the courts in the Tel-Aviv, Israel.
