END USER LICENSE AGREEMENT IS FOR ALL LOGINEXT'S MOBILE AND WEB APPLICATIONS AND ALL ITS VERSIONS WHICH OFFERS A LOCATION BASED REAL-TIME TRACKING AND ANALYTICS SOLUTION. BY DOWNLOADING, INSTALLING, COPYING, ACCESSING OR USING THE SOFTWARES, YOU AGREE TO THE TERMS OF THIS END USER LICENSE AGREEMENT. IF YOU ARE ACCEPTING THESE TERMS ON BEHALF OF ANOTHER PERSON OR COMPANY OR OTHER LEGAL ENTITY, YOU REPRESENT AND WARRANT THAT YOU HAVE FULL AUTHORITY TO BIND THAT PERSON, COMPANY OR LEGAL ENTITY TO THESE TERMS.

INTRODUCTION

This End User License Agreement ("EULA") is entered into as of the date of download ("Effective Date") by and between Loginext Solutions Private Limited ("LogiNext"), a company incorporated under The Companies Act, 2013, having its registered office at 1901, Happiness, City of Joy, Mulund West, Mumbai 400080, and the person, company or entity ("User") who downloads, installs or uses

the mobile or web application for any purpose including for the purposes of inter-operability or individual investigation.

Whereas, LogiNext has developed a proprietary solution using map data, and the related proprietary technology to track, search, manipulate, calculate and display the location data via web and mobile interface; Whereas, User desires to download, install or use the LogiNext Mobile Applications and LogiNext Subscription Service (as those terms are defined below);

Now Therefore, in consideration of the terms and conditions set forth herein, LogiNext and User agree as follows:

1. DEFINITIONS

- "User's Internal Computers" shall mean any computer server or standalone computer within Client's control and located in buildings or premises used for internal work and work related activities.
- "Confidential Information" shall mean any confidential or proprietary information of LogiNext, including but not limited to, information regarding LogiNext's products, data, images, software, applications, specifications, libraries, utilities, services, technology, business, the LogiNext Subscription Service, any feedback provided by User, and the terms and conditions of this Agreement.
- "Intellectual Property Right" shall mean any patent, copyright, trademark, or trade secret rights, or any other intellectual property right or proprietary rights in any invention, information, know-how, or technology, whether now known or hereafter recognized, and whether registered or unregistered.

2. RIGHTS & RESTRICTIONS

- User shall not use the LogiNext Mobile Applications or the LogiNext Subscription Service in contravention of this Agreement or applicable laws.
- User acknowledges that the LogiNext Mobile Applications and LogiNext Subscription Service contain valuable trade secrets of LogiNext. Accordingly, except as expressly permitted herein, User will not (i) transfer, assign, sublicense, distribute, or provide access the LogiNext Subscription Service or LogiNext Mobile Applications, (ii) reproduce, modify, or create derivative works of any images provided with the LogiNext Subscription Service or LogiNext Mobile Applications, or (iii) disassemble, decompile or otherwise reverse engineer any LogiNext Mobile Applications or LogiNext Subscription Services.

3. OWNERSHIP

As between the User and LogiNext ("Parties"), LogiNext owns all right, title, and interest in and to the LogiNext Mobile Applications and LogiNext Subscription Service, including all Intellectual Property Rights therein. There are no implied licenses granted under this Agreement. Nothing contained herein shall be construed as conferring upon User any right to use in advertising, publicity or other marketing activities, any name, trade name, trademark, logo, or other designation of LogiNext. When User downloads the app, uploads, submits, stores, sends or receives content to or through LogiNext Mobile Application or Subscription Services, User gives LogiNext (and those we work with) a worldwide license to use, host, store, reproduce, modify and create derivative works (such as those resulting from translations, adaptations or other changes LogiNext makes so that its services work better).

4. LIMITATION OF LIABILITY

IN NO EVENT WILL LOGINEXT BE LIABLE TO USER OR ANY THIRD PARTY FOR ANY INCIDENTAL, INDIRECT, SPECIAL, CONSEQUENTIAL OR EXEMPLARY DAMAGES, INCLUDING LOST PROFITS, LOST DATA OR LOST REVENUE ARISING FROM OR RELATED TO THIS AGREEMENT OR THE LOGINEXT SUBSCRIPTION SERVICE OR LOGINEXT MOBILE APPLICATIONS, HOWEVER CAUSED AND REGARDLESS OF THE FORM OF ACTION, WHETHER IN CONTRACT OR TORT OR OTHERWISE, EVEN IF LOGINEXT HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
