# **END-USER LICENSE AGREEMENT**

This Ekran System<sup>®</sup> End-User License Agreement (further referred to as "this EULA") is a legal agreement between you (either as an individual or as a legal entity) and Ekran System Inc. for the Product identified above, which includes without limitation: a) all of the contents of the files, disk(s), CD-ROM(s) or other media with which this EULA is provided (further referred to as "the Software"); b) all successive upgrades, modified versions, modified modules, revisions, patches, enhancements, fixes, modifications, copies, additions or maintenance releases of the Software, if any (further referred to as collectively as "the Updates"); and c) related user documentation and explanatory materials or files provided in written, "online" or electronic form (further referred to as "the Product"). By installing, copying, or otherwise using the Product, you agree to be bound by the terms of this EULA. If you do not agree to the terms of this EULA, do not install or use the Product.

BEFORE YOU CLICK THE "I AGREE" BUTTON, PLEASE READ THE TERMS AND CONDITIONS OF THIS AGREEMENT CAREFULLY, AS THIS ACTION IS EQUIVALENT TO YOUR SIGNATURE AND BY CLICKING THE "I AGREE" BUTTON, YOU ARE CONSENTING TO BE BOUND BY AND BECOMING A PARTY TO THIS AGREEMENT AND YOU AGREE THAT THIS AGREEMENT IS ENFORCEABLE IN THE SAME WAY AS ANY WRITTEN NEGOTIATED AGREEMENT SIGNED BY YOURSELF. IF YOU DO NOT AGREE TO ALL OF THE TERMS OF THIS AGREEMENT, CLICK THE "CANCEL" BUTTON AND THE PRODUCT WILL NOT BE INSTALLED ON YOUR CLIENT DEVICE, AS DEFINED IN THEIR TERMS BELOW.

## **1. DEFINITIONS**

"Licensed version" means a version of Ekran System 
<sup>®</sup> that has been licensed for use by an individual, or commercial or non-commercial entity. A licensed version is not free-of-charge and you are not allowed to distribute it in any ways.

"License" means a license that you own. If you haven't purchased a license (i.e. the licensed version) you are bound by the restrictions of an unlicensed (Trial) version.

"The License Agreement", "this Agreement", "this EULA" means this document. This License Agreement is a legal agreement between you (either as an individual or as a legal entity) and Ekran System Inc.

## **2. GRANTING OF LICENSES**

#### 2.1. Licensed Versions and License Types.

When you purchase a license, you will be provided with a license key or a list of license keys. You should enter the license key(s) as prompted by the Software. This licensed version of the Software may be used to record concurrent sessions on terminal server(s) and/or workstation(s) as indicated in your license key(s) and configured by you.

There are four (4) basic types of licenses issued for using Ekran System®, these are:

a. A Terminal Server Client license. This license can be assigned to a terminal server endpoint running any Windows-based server operating system with terminal services (e.g.

Windows Server with terminal services, Citrix Server, or Published App Server, including those deployed

in the cloud on Microsoft Azure or Amazon Web Services). It allows the recording of any number of concurrent terminal sessions running on the licensed server endpoint.

b. An Infrastructure Server Client license. This license can be assigned to a server endpoint running the Windows Server operating system, including those deployed in the cloud on Microsoft Azure or Amazon Web Services, and allows the recording of up to two (2) concurrent sessions running on this endpoint.

c. A Linux/Unix Server Client license. This license can be assigned to a server endpoint running the Linux operating system or Unix operating system, including Oracle Solaris and IBM AIX systems. It allows the recording of any number of concurrent sessions running on the licensed server endpoint.

d. A Workstation Client license. This license can be assigned to a workstation or virtual desktop running the Windows desktop operating system or macOS operating system and allows the recording of one (1) local or remote session.

The license types mentioned above can be combined in the user infrastructure. Purchased licenses can be freely transferred between user infrastructure objects.

## 2.2. The Trial Version.

An individual or legal entity may use a (limited) trial version of the Product free-of-charge for thirty (30) days from the day that the Product is installed with the trial key. The trial version includes a fixed limited number of licenses, namely three (3) Workstation Client licenses, one (1) Terminal Server Client license, and three (3) Linux/Unix Server Client licenses.

To continue to use the full-functional version of the Product after the thirty (30) day evaluation period, you must pay the license fee for the licenses and register your copy. To do this, you should contact your trade representative or buy the licenses directly from: **www.ekransystem.com**.

## 2.3. The Term and Termination of this EULA.

The Term of this EULA (further referred to as ("the Term") shall begin when you download, access or install the Product or pay the applicable license fees (whichever is sooner) and shall continue for the Term specified in your order. Without prejudice to any other rights, this EULA will terminate automatically if you fail to comply with any of the limitations or other requirements described herein. Upon termination or expiration of this EULA, you must immediately cease use of the Product and destroy all copies of the Product.

## 2.4. No Rights Upon Termination.

Upon termination of this EULA, you will no longer be authorized to operate or use the Product in any way.

## **3. DISTRIBUTION**

You are not licensed to make copies of the Product or any of its component parts as you wish, provide copies of the original Product or any of its component parts to any third party, or

distribute the Product or its component parts in any form (modified/unmodified) via electronic means (Internet, BBSs, shareware distribution libraries, CD-ROMs, etc).

## 4. RESTRICTIONS

## 4.1. Restrictions on Actions with the Product.

You may not reverse engineer, decompile, or disassemble the Software as a Product part, nor may you rent, lease, or lend the Product to any third party.
