#### 1. Terms

These Terms of Service (these "Terms") are made by and between the party on whose behalf they are accepted ("User") and Appbase and are effective as of the date they are accepted by User. By accessing the appbase.io website and Appbase services, you are agreeing to be bound by these Terms and Conditions of Use, all applicable laws and regulations, and agree that you are responsible for compliance with any applicable local laws. If you do not agree with any of these terms, you are prohibited from accessing this site or using the services offered by it. # 3. User And Account Requirements

Subject to the terms and conditions of any additional customer agreement that may govern your use of the Services, if and as applicable, you may cancel the Appbase Services at any time. In any such event, Appbase will prorate the fees owed by you for the Appbase Services based on the day of the particular month in which you cancel the Services. Appbase will bill your credit card for the prorated amount immediately on cancellation.

Appbase may change the fees and charges then in effect by sending you notice to the email address registered to your Account. Your subscription to the Services will renew automatically, unless you notify us by mail or email of your decision to terminate your subscription of the Services, or we terminate your Account pursuant to these Terms. - Does not infringe or violate the intellectual property or proprietary rights of Appbase or any third party;
- Is not for any unlawful purpose or in furtherance of illegal activities (international users agree to comply with all local laws regarding online conduct and acceptable content);
- Does not violate any contractual obligation;
- Does not contain software viruses, malware/phishing, or another other computer mechanism designed to disrupt, damage, monitor, or interfere with the independent functioning of Appbase or third party equipment, software, or systems;
- Does not include any personal identification, financial, or confidential information of any other person or entity without prior consent; and
- Does not breach any of the terms or conditions of these Terms or the Privacy Policy.

Appbase reserves the exclusive right to determine whether your use of the Appbase Services or information you post or make available on the Appbase Services falls within any of the prohibited categories listed above.
