



## End-User License Agreement (EULA)

## **6. Warranty Disclaimer**

The Licensed Software is provided "as is," without warranties of any kind. Licensor disclaims all warranties, express or implied, including but not limited to the implied warranties of merchantability and fitness for a particular purpose.

## **7. Limitation of Liability**
