WING FREEMIUM PLATFORM TERMS OF SERVICE

1. Acceptance and Applicability.

- 1.1. By the earlier of (i) checking in the applicable check box or pressing the applicable "I accept" button, or (ii) I first using or attempting to use the Freemium Platform (as defined below) ("Effective Date"), you ("User agree to be bound by the Wing freemium platform terms of service ("Freemium Terms of Service"). If User entering into these Freemium Terms of Service on behalf of a company or other legal entity, such Us represents and warrants that User has the authority to bind such entity to these Freemium Terms of Service.
- 1.2. 5. <u>Changes to the Services; Suspension of Account; Account Cancellation.</u>

- 5.1. Wing may at any time and for any reason modify, correct, amend, enhance, improve, reduce, replac discontinue, or make any other changes to the Services (or any part thereof), at its sole discretion.
- 5.2. At Wing's discretion, Wing may block User's access to the Services and/or limit, suspend or terminate User User Account without any liability to User or to any third party.
